\_\_\_\_\_ All our artists are Independent Contractors. The 911 Stylist is not responsible for the artist's work. We have the best artists in the industry with impressive portfolios, resumes. Talent, work ethic and professionalism. They are responsible for their own work.

\_\_\_\_\_ The 911 Stylist reserves the right to terminate a contract due to harassment or a client making it difficult for the artist to fulfill their job to the best of their abilities.

\_\_\_\_\_ The deposit is NON- REFUNDABLE. It secures the time contracted based on the services that have been contracted.

\_\_\_\_\_ There is a \$25 per hour early morning fee per artist. Every hour before 8 am.

\_\_\_\_\_ There is a 4% fee on all credit card transactions.

\_\_\_\_\_ Client is responsible for parking fees.

\_\_\_\_\_ In the event that additional services are necessary, we will provide clients with an estimate prior to commencing such services. Should we determine that additional assistants are needed for the day of the wedding due to factors such as guest count, venue type and/or amount of time required, clients shall be responsible for additional cost of each additional assistant at the rate of two hundred-fifty (\$250) per assistant.

## CANCELLATION POLICY

PLEASE INITIAL IF YOU AGREE WITH THE FOLLOWING

\_\_\_\_\_ There is a 30 -DAY CANCELLATION PERIOD. Any services that are contracted and decide to cancel within the 30 days, there is a FULL CHARGE. You may replace the contracted services with other services if needed. Please make sure the parties that are on the contract are committed and will not cancel. If the client wants to completely cancel the contract within 30 days, there will be a full charge of contracted services.

\_\_\_\_\_ We are on the clock. We have arrived on time and unable to perform the agreed to services at no fault of The 911 Stylist (ex: Party arrives late, hotel or lodging issues, bad weather etc. Be advised there will be WAIT RATE of \$100 per hour to be billed in 15-minute increments applied to the final invoice. PLEASE make sure everyone is arriving and is prepared on time. We have accommodated the schedule to ensure your party is satisfied. We CAN NOT guarantee top quality results if the agreed to time frame to perform our services is not met.

You may add services if timing and staffing permits.

\_\_\_\_\_ Please have every one's hair DRY and ready to go. Washed the day before is preferred. Having to take time to dry hair takes extra time and is an extra service.

## POLICIES & FAQ

A trial run can be performed prior to the signing of the contract to ensure satisfaction, or you have the option to sign the contract to secure your date with or without a trial. A trial is recommended but not mandatory.

We conduct trials Monday Through Fridays : 9 am - 4 pm

Weekends are reserved for weddings & special events.

Our clients book typically a year in advance and we cannot hold your event date without the contract signed and credit card number.

If the timeline exceeds the quoted contract timeline on the client's behalf, a \$24.99 hourly rate per stylist will apply as to keep us on track for other potential events scheduled that day.

If the bridal party is late for the start time on the contract we will do our best in the time remaining to complete all the services scheduled. If time runs out before the services are completed, the full amount will still be charged.

We can accommodate any size wedding party. You can reserve us for as many days as needed. Weekends do book fairly quickly so the sooner you book the better.

The party must come with clean, dry hair.

Our fee for having to blow out client's hair starts at \$45.

We provide touch up services and style changing for \$99 per hour. An additional \$49.99/hour for each assistant required for touch ups.

Travel Fees are based on your location. \$50 minimum / .63 Cents per mile for total miles traveled to and from artist's residence.

Parking fees will be added on to your total if applicable.

There is a \$24.99 premium service rate per hour before 8 am per artist.

Holiday bookings (Thanksgiving Holiday- Thurs through Sun, Christmas Eve, Christmas Day, NYE, New Years Day, Independence Day, as well as long weekends including Memorial Day weekend- Fri through Mon & Labor Day weekend- Fri through Mon): Holiday fee is an additional \$199.99 per holiday date.

**LEAD & ALTERNATIVE ARTIST:** In an extreme/unforeseen circumstance such as an "Acts of God", accident, illness, etc. The 911 Stylist reserves the right to have one of their alternative artist perform services in place of prior scheduled artist. In most cases the Lead Artist will work on Bride. If time permits Lead Artist will be perform services on attendants scheduled.

**SERVICE LOCATION AND REQUIREMENTS:** Location of service for the day-of-event will be at the discretion of the client, but there are certain requirements to perform services. A "set up" table/work area needs to be made available for the artist at said location. Working electrical outlets must also be made available for use by artist. Ample lighting, whether by means of natural light or by lamps, is necessary for services to be performed properly. A chair is requested. Climate controlled area for makeup must be granted at all time.

**PEAK SEASON:** Due to heavy volume, The 911 Stylist does not take the "Bride Only Package" during peak bridal/event season of Sept-Dec March- June and on holiday weekends. There are a minimum number amount necessary to book during this time. Exceptions will be made on a case by case basis so please inquire. If less than 5 hair and makeup services are granted during peak seasons The 911 Stylist team will schedule morning or late afternoon time slot in order to accommodate other weddings/events as well.

**MINIMUM:** There is a minimum amount of \$500.00 or Bride Only Package + 2 Adult Hair and/or Makeup services required for an on location wedding. If client does not meet the minimum for on location services in studio appointments maybe available. Each clients needs will be discussed on a case by case basis.

ADDITIONAL FEES, LOSS AND DAMAGES: Where parking, valet or toll fees may be accrued; the amount will be due for payment on the day of the event.

AIRFARE AND ACCOMMODATIONS: All costs for travel to a booked event are to be paid by client. Costs may include, but are not limited to: drive/travel, airfare, hotel, transportation, parking, per diem, service incidentals and all taxes.

LIABILITY: Any skin condition including dehydrated skin should be reported by the client to the makeup artist prior to application and, if need be, a prearranged trial or sample test of makeup may be performed on the skin to test reaction. Client(s) agree to release the makeup artist, The 911 Stylist, and/or any and all of its employees and agents from liability for any skin complications due to allergic or rare reactions. It is the responsibility of client to provide special makeup or products which they require for allergy reasons or sanitation purposes/needs. I.e. personal mascara & lipstick. The 911 Stylist, and/or any and all of its employees and agents can not guarantee the longevity of the overall look when using the clients makeup, hair or beauty products.

GRATUITIES: Gratuities are NOT INCLUDED in the pricing lists. 20% Gratuities (of all services performed) will be added to final payment for clients with 4 or more services. For Agreements containing 3 or less suggested gratuity is 20% (of all services performed). Gratuities can be paid by in cash to individual artists.

Please feel free to add into your payment or to discuss bridesmaids/attendants paying their stylist individually.

PAYMENT: The FINAL balance is due 30 DAYS before the event as one payment - no exceptions. The person(s) responsible for the entire balance of payment is the person(s) who has signed the booking agreement. Acceptable forms of payment are: Credit cards, cash, cashier's check, money order, bank deposit and PayPal payments made payable to The 911 Stylist.

Any final balance not paid **30 DAYS** before the event will incur a 25.00 late fee per day.

SEVERABILITY: If any provision or provisions of this Agreement shall be held to be invalid, illegal, unenforceable or in conflict with the law of any jurisdiction, the validity, legality and enforceability of the remaining provisions shall not in any way be affected or impaired thereby.

RETURNED CHECK: If any check is returned by the bank for non-sufficient funds (NSF) a \$30 fee will be charged on top of bank fees and 100% of all fees agreement. Any booking made under such circumstances, (NSF), is subject to cancellation and any deposits paid will be forfeited.

ONE PARTY CHECK: One check per Event/ Bridal party. Cash will always be accepted however multiple/split checks are not allowed from 3rd party.

DEPOSIT: \$100 non-refundable deposit is required to hold date.
